We have audited the financial statements of the governmental activities, the business-type activities, the aggregate discretely presented component units, each major fund, and the aggregate remaining fund information of Johnson County, Kansas (County), as of and for the year ended December 31, 2021, and the related notes to the financial statements, which collectively comprise the County's basic financial statements, and have issued our report thereon dated June 24, 2022. Professional standards require that we provide you with information about our responsibilities under auditing standards generally accepted in the United States, as well as certain information related to the planned scope and timing of our audit. We have communicated such information in our letter to you dated January 31, 2022. Professional standards also require that we communicate to you the following information related to our audit.

## Qualitative Aspects Of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used are described in Note 1 to the financial statements. During the year ended December 31, 2021, the District adopted the following standard:

• Governmental Accounting Standards Board (GASB) Statement No. 87, *Leases*, which changed the accounting policies for accounting for leases as stated in Note 1 to the financial statements.

During the year, the County changed its accounting practice related to the presentation of its retirement plans. GASB implementation guide 2021-1 question 4.3 clarified the definition of "control" as it pertains to the requirements to report certain defined contribution plans. Implementation of this clarification resulted in the removal of the defined contributions plans as fiduciary funds from the financial statements.

No other new accounting policies were adopted and the application of other existing policies was not changed during the year ended December 31, 2021. We noted no transactions entered into during the year for which there was a lack of authoritative guidance or consensus. There are no significant transactions that have been recognized in the financial statements in a different period than when the transaction occurred. There are no instances where we consider a significant accounting practice that is acceptable under the applicable financial reporting framework not to be most appropriate to the particular circumstances of Johnson County, Kansas.

For purposes of this communication, professional standards require us to communicate to you significant unusual transactions identified during our audit. There were no significant unusual transactions identified as a result of our audit procedures that were brought to the attention of management.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements were:

Management's estimate of the depreciable lives of capital assets is based on estimates of an asset's useful life. We evaluated the key factors and assumptions used to develop the depreciable lives in determining that it is reasonable in relation to the financial statements taken as a whole.

Management's estimate of the estimated liability for claims for general liability, workers' compensation and health insurance are based on estimates and calculations prepared by an actuary that the County hires for the general liability and workers' compensation estimates. For the health insurance estimates, obligations recorded are based on past history of claims recorded and estimates of the lag time between when a claim is filed and paid. We evaluated the key factors and assumptions used to develop these estimates in determining that they are reasonable in relation to the financial statements taken as a whole.

Management's estimate of the liability and other related balances for total other post-employment benefits (OPEB) are based on calculations made by external actuaries. We tested census data and reviewed the actuarial reports for reasonableness, including the methods and assumptions used by the actuaries in their calculations in determining that the estimates are reasonable in relation to the financial statements taken as a whole.

Management's estimate of the liability and other related balances from its participation in the cost-sharing, multiple employer pension plan KPERS is based on calculations made by external actuaries hired by the State of Kansas. We tested census data and reviewed the actuarial reports for reasonableness, including the methods and assumptions used by the actuaries in their calculations in determining that the estimates are reasonable in relation to the financial statements taken as a whole.

Management's estimate of the fair values of investments is based on market data and other inputs. We evaluated the key factors and assumptions used to develop the fair values in determining that they are reasonable in relation to the financial statements taken as a whole.

Management's estimate of the inputs to calculating the lease assets, liabilities and deferred inflows (when applicable) are based on estimates of the interest rates implicit in the leases and the likelihood of lessees exercising options to extend the leases. We evaluated the key factors and assumptions used to develop interest rates implicit in the leases and the likelihood of lessees exercising options to extend the leases in determining that they are reasonable in relation to the financial statements taken as a whole.

The disclosures to the financial statements are neutral, consistent, and clear. Certain financial statement disclosures are particularly sensitive because of their significance to the users of the financial statements. The most sensitive disclosures affecting the financial statements are:

The disclosure of Debt in Note 8 to the financial statements contains the information used to evaluate the debt position of the County.

The disclosure of Fund Balances in Note 9 to the financial statements contains the information used to evaluate the classifications of the fund balances of the County.

The disclosure of Self-Insurance in Note 10 to the financial statements contains the information used to inform readers of information related to the County's risk management.

Circumstances that Affect The Form And Content Of The Auditors' Report

For purposes of this letter, professional standards require that we communicate any circumstances that affect the form and content of our auditors' report. The Auditors' Report contains information about the audit work performed by the component auditors as well as an emphasis of matter related to the implementation of Governmental Accounting Standards Board (GASB) Statement No. 87, *Leases*. The Auditors' report also contains information about the restatement related to GASB No. 84: *Fiduciary Activities*.

## Matters Resulting In Consultation Outside The Engagement Team

During the audit, we coordinated with management of the County and consulted with the GASB related to the application of recent GASB standards and implementation guides related to the presentation of its retirement plans. There were no other significant matters which resulted in consultation outside of our engagement team.

#### Corrected And Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are trivial, and communicate them to the appropriate level of management. Further, professional standards require us to also communicate the effect of uncorrected misstatements related to prior periods on the relevant classes of transactions, account balances or disclosures, and the financial statements as a whole. The attached schedule summarizes uncorrected misstatements of the financial statements. Those uncorrected misstatements are as follows:

- To increase Johnson County, Kansas General Fund expenses and fund balance for \$1,000,000; and Government-Wide expenses and net position for \$1,000,000. This entry is the result of reversing the impact from a prior year passed journal entry related to accounting for a lease, and there is no further impact to future years.
- Fire District No. 2 is currently presented with the other Fire Districts in the aggregate discretely presented component units. Due to recent changes in the governance of Fire District No. 2, generally accepted account principles would require Fire District No. 2 to be blended with the other funds of the County, rather than included in the aggregate discretely presented component units. The impact of classifying Fire District No. 2 as discretely presented rather than blended is not material to the financial statements.
- To increase Johnson County, Kansas Wastewater Enterprise Fund and Business Type Activities Charges for Services \$4,780,256 and decrease opening Net Position \$4,780,256. This total amount does not impact cash balances and is the result of revenue recognition requirements over several periods. This entry is the result of the County management identifying that the mapping from the Orion system to Oracle was not completed properly during the implementation in 2017. The mapping was corrected by management in the current year by flowing the cumulative impact since 2017 through the current year. The amount above includes an estimate of \$943,000 for the amount of Recertification Fees that had not been previously recognized from the same implementation year.

• To increase the Johnson County Park and Recreation District total assets and total liabilities by \$595,201 for a construction invoice that was not accrued at December 31, 2021. The total amount includes a projected amount of \$462,669 due to extrapolating the results of the testing sample. The Johnson County Park and Recreation District is separately audited and included in the financial statement presentation of the County as a discretely presented component unit.

Management has determined these uncorrected misstatements are not material, both individually and in the aggregate, to the financial statements taken as a whole. Uncorrected misstatements or matters underlying those uncorrected misstatements could potentially cause future-period financial statements to be materially misstated, even though the uncorrected misstatements are immaterial to the financial statements currently under audit.

In addition, professional standards require us to communicate to you all material, corrected misstatements that were brought to the attention of management as a result of our audit procedures. We did not identify any corrected misstatements that were identified by us as a result of our audit procedures.

# Disagreements With Management

For purposes of this letter, professional standards define a disagreement with management as a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditors' report. We are pleased to report that no such disagreements arose during the course of our audit.

#### Management Representations

We have requested certain representations from management that are included in the attached management representation letter.

## Management Consultations With Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to an entity's financial statements or a determination of the type of auditors' opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

# Difficulties Encountered In Performing The Audit

We encountered no significant difficulties in dealing with management in performing and completing our audit.

## Other Audit Findings Or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as County's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

This representation letter is provided in connection with your audit of the governmental activities, the business type activities, the aggregate discretely presented component units, each major fund, and the aggregate remaining fund information of Johnson County, Kansas as of December 31, 2021 and for the year then ended, and the related notes to the financial statements, for the purpose of expressing opinions on whether the basic financial statements present fairly, in all material respects, the financial position, results of operations, and cash flows, where applicable, of the various opinion units of Johnson County, Kansas in accordance with accounting principles generally accepted for governments in the United States of America (U.S. GAAP).

We understand we are responsible for management decisions and functions, for designating a qualified employee to oversee any nonattest services you provide, and for evaluating the adequacy and results of the services performed and accepting responsibility for such services.

Certain representations in this letter are described as being limited to matters that are material. Misstatements, including omissions, are considered material if there is a substantial likelihood that individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

We confirm that, to the best of our knowledge and belief, as of the date of this letter, the following representations made to you during your audit:

- 14) All net position components and fund balance classifications have been properly reported.

- 19) Capital assets, including infrastructure assets, are properly capitalized, reported, and if applicable, depreciated.
